



LOCATION DESCRIPTIONS 2020 WAYFINDING SIGNAGE

Schedule 1 - C01A

Sign Type - Civic Amenity Identifier

General Location – Entrance of the Off-Leash Dog Park.

Double Sided – Yes

Front – Olds Off-Leash Dog Park

Back – Olds Off-Leash Dog Park

Special Notes – No known underground utility conflicts are present. Overhead power is in the direct area.

Schedule 2 - C01B

Sign Type – Vehicular Directional

General Location – HWY 27 & 70 Ave. West of 70 about 100 meters

Double Sided – Yes

Front – 5 lines, including 1 symbol, and 1 directional arrow.

Back – Town of Olds Logo

Special Notes – There is an inactive power high voltage power line in the ditch somewhere. Co-ordination with Fortis, Alberta Transportation, Contractor, and The Town is required. Fortis may require the inactive line to be exposed.

Schedule 3 - C01C (Provisional)

Sign Type - Civic Amenity Identifier

General Location – 70 Ave & 40 St.

Double Sided – Yes

Front – Rotary Athletic Park of Olds

Back – Rotary Athletic Park of Olds

Special Notes – There is an underground power line in the dig area of this sign. Exposing of this line is mandatory. The power line is approximately 1 meter north of the back of sidewalk.

Schedule 4 - C01D

Sign Type – Neighbourhood Identifier

General Location – North of Wal-Mart. At SW corner of parking lot at new playfields.

Double Sided – Yes

Front – Rotary Athletic Park of Olds

Back – Rotary Athletic Park of Olds

Special Notes – There is an underground power line in the dig area of this sign. Exposing of this line is at the discretion of Fortis. The power line is approximately 1 meter north of the back of sidewalk.

Schedule 5 - C02A

Sign Type – Vehicular Directional

General Location – HWY 27 & 57 Ave. East side of the intersection. By Circle K.

Double Sided – Yes

Front – 5 lines, including 1 symbol, and 1 directional arrow.

Back – Town of Olds Logo

Special Notes – N/A

Schedule 6 - C02B

Sign Type – Vehicular Directional

General Location – HWY 27 & HWY 2A East side of the intersection.

Double Sided – Yes

Front – 5 lines, including 1 symbol, and 1 directional arrow.

Back – Town of Olds Logo

Special Notes – N/A

Schedule 7 - C02C

Sign Type - Civic Amenity Identifier

General Location – 4512 46 Street. Olds, AB

Double Sided – Yes

Front – Town of Olds Administration (SUBJECT TO CHANGE)

Back – Town of Olds Administration

Special Notes – Removal and disposal of the existing sign is required. Disconnection of existing electrical line, and installation of a new junction box within the excavated area to spool the excess wire in for future connection and use.

Schedule 8 - C03A

Sign Type – Vehicular Directional

General Location – 54 Street & HWY 2A. North Side of the intersection.

Double Sided – Yes

Front – 5 lines, including 1 symbol, and 1 directional arrow.

Back – Town of Olds Logo

Special Notes – N/A

Schedule 9 - C03B

Sign Type – Vehicular Directional

General Location – 54 Street & HWY 2A. South side of intersection.

Double Sided – Yes

Front – 5 lines, including 1 symbol, and 1 directional arrow.

Back – Town of Olds Logo

Special Notes – N/A

Schedule 10 - C03C (Provisional)

Sign Type - Civic Amenity Identifier
General Location – 4512 46 Street. Olds, AB
Double Sided – Yes
Front – Olds Aquatic Center
Back – Olds Aquatic Center
Special Notes – N/A

Schedule 11 - C03D

Sign Type – Vehicular Directional
General Location – South of 57 St & HWY 2A 120 meters on East side of the road.
Double Sided – Yes
Front – 5 lines, including 1 symbol, and 1 directional arrow.
Back – Town of Olds Logo
Special Notes – N/A

General Notes:

- Contractors are responsible for the locate, exposing, and protecting of all shallow utilities. Alberta One Calls do NOT include Shaw Cable, and it is the responsibility of the contractor to locate all possible shallow utilities, both registered with Alberta One Call and those that are not registered with Alberta One Call.
- Contractors are to submit shop drawings of each sign for approval by the Town Prior to printing of signs.
- Warranty period of 2 years from time of CCC is required.
- Contractor, Town Representative, and Alberta Transportation Representative are to establish final sign locations for all signs along the provincial highway prior to construction.
- Logo on the back of the Vehicular Directional is the Black and White image below. Sizing of the image is yet to be determined.
- The Town is working on the comprehensive list of direction items that are to go on the Vehicular Directional Signage. It is anticipated to be prepared shortly after the award of the contract.
- The Town encourages contractors to provide a symbol library that indicated amenities.
- The Town encourages contractor involvement in decisions, and any alterations that may be necessary. If the contractor feels there are any “value added” items or changes that they have identified during to RFP process, we encourage contractors to identify these items separately from the quantity document.
