Principal Contractor with more than 3 sub-trades and subcontractors	\$750.00 per Calendar Year
Flea Markets (Resident & Non-Resident).....	\$125.00 per event
Resident Business/Single Contractor Temporary (≤ 4 consecutive weeks).....	\$25.00
Non-Resident Business/Single Contractor Temporary (≤ 4 consecutive weeks)...	\$50.00
Transfer Fee.....	\$20.00
Administrative Fee for Refund Request.....	\$20.00

*Where a Resident Business operates only after June 30 of any License year, the fees charged shall be 50% the fee shown on Schedule "A", with the exception of Temporary licenses, which will be as shown on Schedule "A".

*If a Resident Business, with a current Business License, closes prior to July 1 of any License year, a refund of 50% the fee as set out in Schedule "A" shall be refunded to the Business owner upon request of the Licensee.
