PUBLIC NOTICE TO ELECTORS OF THE TOWN OF OLDS, PROVINCE OF ALBERTA

SECTION 251 - THE MUNICIPAL GOVERNMENT ACT

TAKE NOTICE that the Council of the Town of Olds, in the Province of Alberta, has given first reading to borrowing By-law No. 2019-12 which will, upon final passage and approval, authorize the proper officers of the said Town of Olds to borrow monies from the Alberta Capital Finance Authority by way of debenture issue, to pay for the cost of the following municipal purpose(s), namely for the construction of a new operations center including the reclamation of the existing wastewater treamtment center lands located within the limits of the Town of Olds. The total cost of the aforesaid project amounts to \$10,734,023. The net amount to be borrowed on the credit and security of the municipality at large by the issue of debentures is \$10,734,023. The debentures are to be repayable to the Alberta Capital Finance Authority in sixty (60) equal consecutive semi-annual instalments of combined principal and interest, the semi-annual interest not to exceed ten per centum (10%), or the interest rate as fixed from time to time by the Alberta Capital Finance Authority;

NOW THEREFORE NOTICE is hereby given by the Council of the Town of Olds that, unless a petition of the owners for a vote on By-law No. 2019-12 is demanded, as provided for by the terms of Section 231(1) of the Municipal Government Act, the said Council may pass the said borrowing by-law.

All persons interested are hereby notified and they are required to govern themselves accordingly.

INFORMATION FOR ELECTORS

Pursuant to Section 1(i) of the Municipal Government Act an "elector" means:

1. A person who is eligible to vote in the election for a councillor under the Local Authorities Election Act.

Pursuant to section 47(1) of the Local Authorities Election Act a person is eligible to vote in an election if he:

a) is at least 18 years old,

b) is a Canadian citizen, and

c) has resided in Alberta for the 6 consecutive months immediately preceding election day and is resident in the area on election day.

A poll may be demanded in the Town of Olds by electors equal in number to at least a) in the case of a municipality other than a summer village, by electors of the municipality equal in number to at least 10% of the population and

b) in the case of a summer village, by 10% of the electors of the summer village in accordance with the provisions of section 223 of the Municipal Government Act and in accordance with the provisions of section 251 of the Municipal Government Act.

The petition for a vote must be received by the Chief Administrative Officer within 15 days of the last publication of this notice and shall contain on each page "an accurate and identical statement of the purpose of the petition". (Further requirements of the petition are provided in section 224 of the Municipal Government Act.)

Help Combat Dandelions

PROMOTE A HEALTHY LAWN

Dandelions are, first and foremost, some of the world's most effective opportunists – they thrive in poor soils and quickly move in where other vegetation has moved out – like a thinning lawn. Once established, it's only a matter of time before seed heads are produced to flood the property with thousands of dandelion seeds.

The best defense against dandelions is a thick lawn that is properly cared for and well-fed. A thick lawn will be better able to choke the weeds and not allow them to establish. By promoting a dense, healthy lawn and allowing it grow a little taller (skip the buzz cut!), homeowners can create a habitat that's uninviting to dandelions!

MOW OFTEN!

While it won't necessarily kill the dandelions that are already present in the lawn, homeowners can dramatically reduce the number of new dandelions that appear simply by mowing often. - at least once a week to stay on top of things, and to keep them from establishing in the first place.

Like many weeds, dandelions rely on wind dispersal to spread their seeds, sending up tall flower and seed stalks to better catch the breeze. By mowing regularly, homeowners can remove the majority of dandelion flowers before they have a chance to transform into the white puff-balls so many people love to hate.

The Town of Olds invites applications for a full-time Building Safety Codes Officer. Reporting to the Director of Operations, the Building Safety Codes Officer is responsible for the implementation of the Town of Olds Quality Management Plan (QMP) – Building. The QMP forms the basis of the Town of Olds process as it relates to building inspections and plan examination to ensure compliance with applicable legislation and code to help protect the health and safety of our community. Working as part of a team with individuals in Planning & Development, and the Fire Prevention Officer – Inspector, the Building Safety Codes Officer will perform plan reviews as development and building permit applications are received, perform inspections and prepare deficiency lists and/or issue stop work orders related to all parts of the Alberta Building Code and National Energy Code of Canada for Buildings. This position will also provide code advice to members of the public.
