

## NOTICE OF PUBLIC HEARING **REGARDING PROPOSED BYLAW NO. 2023-07**

Bylaw No. 2023-07 proposes a site-specific amendment to the Town of Olds Land Use Bylaw to allow 'mixed use development' as a permitted use on the property of 5034 49 Street (Lot 23, Block 2, Plan 868E). The proposed amendment will allow for a residential unit on the main floor of the subject site.

Council will hear submissions made in person or by the agent from any person who claims to be affected by the proposed bylaw. Comments received prior to 4:00 p.m. on April 3, 2023 will be included in the staff report to Council and comments received after will be read at the public hearing. The Town of Olds intends to pursue remedies, including but not necessarily limited to those found at sections 37 and 39 of the Municipal Government Act, to have the construction, maintenance or repair of the service connection brought to standards satisfactory to the Town of Olds. The remedies to be pursued by the Town of Olds also include having the costs of completing the required work to the service connection be paid for by the registered owner of the lands legally described as Plan 7063JK, Lot A, in accordance with the Municipal Government Act.

The notice is hereby given that under the provision of the Municipal Government Act, the Town of Olds may, after the public auction, become the owner of any parcel of land that is not sold at the public auction.
