5A) Borrowing Bylaw 2019-12 New Operations Centre

7A) West Towne - DCMU1 Comprehensive Site Plan

Development Officer, Carey Keleman presented highlights to Council on information as contained in the agenda package on the West Town comprehensive site plan. Centcom Construction Ltd. is proposing a commercial/mixed-use development which will be named West Towne. The plan includes developing West Towne in three (3) phases. Phase 1 will be comprised of the construction of seven (7) commercial buildings with the following uses These 7 buildings will amount to 33 commercial bays.

The main access into the proposed West Towne development will be off of 70 Avenue. The applicants are also proposing a right-in turn only off of Highway 27 when heading west. This is pending Alberta Transportation approval. Discussions with Alberta Transportation and the Town of Olds are underway.

General discussion ensued on access to the development from 70th Avenue and Highway 27 and controlled intersections, and developer contributions.

Councillor Harper wanted it noted that she is not in favor of a 'right in only' off Highway 27 for this development.

Moved by Councillor Harper, "that Council approve the West Towne Comprehensive Site Plan at 6920 – 46 Street, in the Direct Control Mixed Use 1 land use district." <u>Motion Carried 19-170</u>

7B) Development Permit 19-050

Development Officer, Carey Keleman presented highlights to Council on information as contained in the agenda package on the development permit application for 19-050. Phase 1 will be comprised of the construction of seven (7) commercial buildings with the following uses - indoor merchandise sales, personal services, cannabis retail sales; restaurant; drive-through; financial services; office; professional, financial and office support services; signs; and liquor store. These 7 buildings will amount to 33 commercial bays.

Moved by Councillor Overwater, "that Council approve Development Permit application 19-050 subject to the conditions listing the attached Development Permit."
